**TO DESIGNATE AS "RESERVED SECTION LINE"
THE N/2 OF S.W. 89TH STREET BETWEEN
SOUTH PORTLAND AVENUE AND I-44 HIGHWAY**

WHEREAS, The City of Oklahoma City ("City") desires to have placed in reserve status the N/2 of S.W. 89th Street between South Portland Avenue and I-44 Highway more particularly described on the Exhibit "A" attached hereto;

WHEREAS, the portion of the section line described on Exhibit "A" abuts property owned by the City and leased to the Oklahoma City Airport Trust for airport purposes;

WHEREAS, the south portion of the section line described on Exhibit "A" is located within Cleveland County and Cleveland County has expressed its intent to place the south portion of the section line on "reserve status";

WHEREAS, The City of Oklahoma City has closed the property described on Exhibit "A" for public use pursuant to Ordinance No. 24,205 for safety reasons in order to develop and expand the airport;

WHEREAS, the remainder of S.W. 89th Street from the west right-of-way line of South Portland to the east right-of-way line of South MacArthur Boulevard has previously been closed and vacated and creates an impassible barrier for public use;

NOW THEREFORE BE IT RESOLVED that the Board of County Commissioners hereby designates as reserved section line the N/2 of S.W. 89th Street between South Portland Avenue and I-44 Highway more particularly described on the attached Exhibit "A".

BE IT FURTHER RESOLVED that this Resolution take effect immediately upon approval by the Board of County Commissioners and filing of record in the Office of the County Clerk of Oklahoma County, Oklahoma.

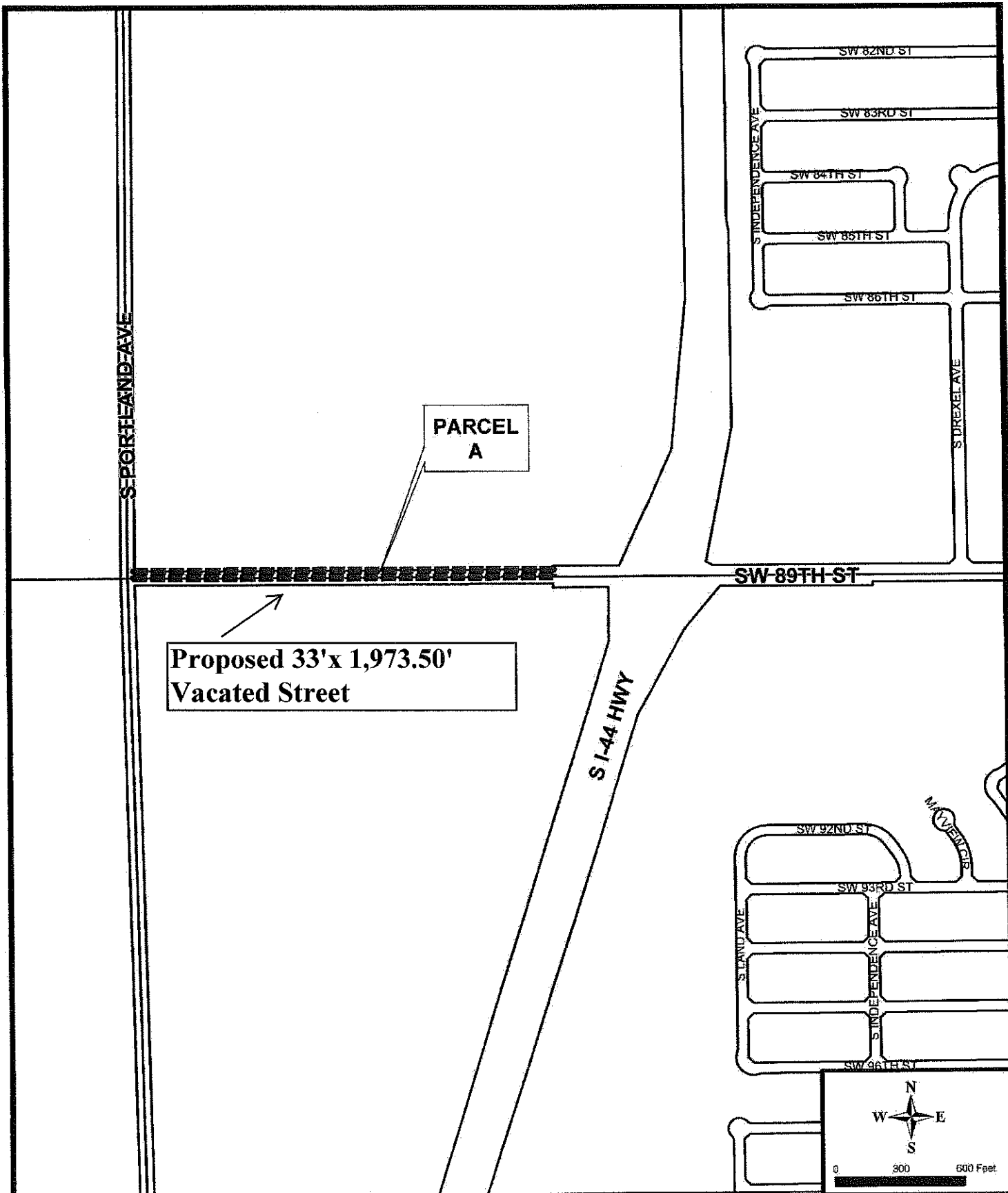
